**MOTION OF ADVISORS TO CONTINUE DATE TO CONVENE  
STATUS CONFERENCE CALL**

Now come Advisors to the Council of the City of New Orleans (“Advisors”), who respectfully request that the procedural schedule in the captioned proceeding be modified and amended with the following date.

Counsel for the Advisors filed an Unopposed Motion of Advisors to Amend Procedural Schedule in the matter on September 5, 2018. The motion was granted by the Hearing Officer on September 10, 2018 and the order included a deadline of November 9, 2018 for the parties to convene a status conference call for the purpose of proposing additional dates in the schedule. ENO recently retained the services of Quanta Technology, LLC (“Quanta”) to perform an evaluation of certain aspects of ENO's distribution system as they relate to reliability. Quanta prepared a report based on its evaluation and ENO filed Quanta's report in this docket on October 31, 2018. The Council's Advisors are continuing to review and analyze Quanta's report and request that the November 9, 2018 deadline to convene a status conference call be extended by one week or until (on or before) Friday November 16, 2018.

Therefore, the Advisors request that the remaining date be suspended and that the schedule be amended and supplemented as reflected below:
