ENTERGY NEW ORLEANS, LLC'S UNOPPOSED MOTION TO MODIFY THE PROCEDURAL SCHEDULE

Entergy New Orleans, LLC ("ENO") respectfully submits this Unopposed Motion to Modify the Procedural Schedule in the above-captioned Docket. Specifically, for the reasons stated herein, ENO requests that the dates set forth in Council Resolution No. R-19-111 at Ordering Paragraph 3(C) be modified as follows: (i) that the date by which ENO shall file its proposed Community Solar Plan, CSG Application Procedure, and Standard Interconnection Agreement for CSG Facilities be changed from July 30, 2019 to August 29, 2019, (ii) that the date on which the parties must submit comments on ENO's Community Solar Plan, CSG Application Procedure, and Standard Interconnection Agreement for CSG Facilities be changed from August 29, 2019 to September 28, 2019, and (iii) the date on which ENO shall file Reply Comments be changed from September 13, 2019 to October 15, 2019.

1.

On June 21, 2018, the Council initiated Docket UD-18-03 via Council Resolution No. R-18-223. Resolution No. R-18-223 established certain procedural deadlines, appointed the Honorable Jeffrey Gulin as the Hearing Officer in this Docket, and vested Judge Gulin with the authority to "change or amend the procedural dates" set forth in the Docket.

2.

On March 28, 2019, the full Council adopted Resolution No. R-19-111, which set forth additional procedural deadlines for this Docket.

3.

On April 8, 2019, ENO filed an Unopposed Motion to Modify the existing Procedural Schedule as set forth in Resolution No. R-19-111 as follows: (i) that the date by which the meeting of the parties must occur be changed from May 1, 2019 to June 1, 2019, and (ii) that the date on which ENO must submit "its proposed CSG application procedure and its proposed Standard Interconnection Agreement for CSG facilities" be changed from May 1, 2019 to July 30, 2019. The Hearing Officer granted ENO's motion on April 9, 2019.

4.

ENO conducted the required meeting of the parties on May 30, 2019 and discussed with the parties several open items that needed to be resolved prior to the completion and filing of ENO's proposed Community Solar Plan, CSG Application Procedure, and Standard Interconnection Agreement for CSG Facilities. ENO continues to work diligently to resolve these issues, but it has become apparent that more time will be required to complete this work and prepare ENO's proposed Community Solar Plan, CSG Application Procedure, and Standard Interconnection Agreement for CSG Facilities for filing with the Council. As such, ENO requests an extension of thirty (30) days to the deadline for filing its proposed Community Solar Plan, CSG Application Procedure, and Standard Interconnection Agreement for CSG Facilities.

As noted in ENO's April 8, 2019 Motion, this latter modification was necessary to correct an editing error

with Resolution No. R-19-111 that resulted from the Resolution being modified during the interim between the time that the Utility, Cable, Technology, and Telecommunications Committee ("UCTTC") acted on the Resolution in December 2018 and when the full Council approved the Resolution in March 2019.

5.

ENO's requested extension would also necessitate changing the deadlines set forth in Ordering Paragraphs 3(C)(i) and 3(C)(ii) of Resolution No. R-19-111, as those deadlines are derived from the filing of ENO's proposed Community Solar Plan, CSG Application Procedure, and Standard Interconnection Agreement for CSG Facilities.

6.

ENO has contacted the parties to this Docket seeking any objections to the requested relief sought herein. As of the filing of this Motion, no party has objected to the relief requested.

WHEREFORE, Entergy New Orleans, LLC respectfully requests that its Unopposed Motion to Modify the Procedural Schedule be GRANTED and that the dates set forth in Council Resolution No. R-19-111 be modified as follows: (i) that the date by which ENO shall file its proposed Community Solar Plan Community Solar Plan, CSG Application Procedure, and Standard Interconnection Agreement for CSG Facilities be changed from July 30, 2019 to August 29, 2019, (ii) that the date on which the parties must submit comments on ENO's Community Solar Plan CSG Application Procedure, and Standard Interconnection Agreement for CSG Facilities be changed from August 29, 2019 to September 28, 2019, and (iii) the date on which ENO shall file Reply Comments be changed from September 13, 2019 to October 15, 2019.
