MOTION TO EXTEND THE DATE TO FILE ADVISORS' REPORT

The Advisors to the Council of the City of New Orleans ("Council"), through undersigned counsel, respectfully submit this Motion to Extend the Date to File Advisors' Report in the above-captioned proceeding. On September 15, 2022, the Council adopted Resolution No. R-22-413, initiating a new rulemaking proceeding and procedural schedule to consider savings targets and program design for energy efficiency, conservation, demand response and other demand-side management programs as well as customer-owned distributed energy resources and battery storage. The resolution directed the Advisors to submit on February 1, 2023 an Advisors Report summarizing the comments received, the resulting changes to existing Council policies, and additional guidance to the Parties on how to fulfill the Council's goals for the docket. Due to pressing deadlines in other matters, the Advisors find that they require additional time to consult with CURO and prepare the Advisors' Report. Given that Mardi Gras falls on February 21, 2023, the Advisors are requesting a one-month extension of time (from February 1, 2023 to March 1, 2023) to file their report.

The one-month extension would necessitate a similar extension of the remaining deadlines in the docket. Conscious of where significant spring religious holidays fall in April, the Advisors propose that the remaining procedural schedule be extended as follows:
