

REPORT REGARDING PUBLIC OUTREACH MEETINGS

Entergy New Orleans, Inc. ("ENO"), through undersigned council, submits this Report Regarding Public Outreach Meetings pursuant to Council Resolution R-17-426, dated August 10, 2017. The Council, in Resolution R-17-426, directed ENO to conduct a minimum of 5 public outreach meetings prior to December 4, 2017 for the purpose of sharing information with, and answering questions from, the public related to the proposed New Orleans Power Station. The Resolution also directs ENO to provide notice of the outreach meetings no later than 15 days prior to each meeting and such notification shall be published in the *Times Picayune*, *Gambit*, *The New Orleans Advocate*, *The New Orleans Tribune*, and on ENO's website.¹

ENO submits this Report to demonstrate its efforts, to date, to comply with Resolution R-17-426, including all publication requirements.² Following the meetings, the Resolution requires ENO to submit a report outlining the dates, times, and locations of each meeting, including a list of individual attendees and representatives of any community, civic, or other organizations present at the meetings. Due to the fact that the Resolution was issued on August 10, 2017, and

ENO held three meetings prior to that date, ENO is submitting this Report more than 7 days after those meetings, but within seven days of the issuance of the Resolution. For all future meetings, ENO will file Supplemental Reports within the seven day time period set forth in the Resolution.

The first public outreach meeting was held on July 31, 2017 (6:00 p.m.), at the East New Orleans Library, located in District E at 5641 Read Blvd., New Orleans, Louisiana, 70127. Approximately forty-five individuals attended. While individuals in attendance did not disclose their affiliation with any community, civic, or other organizations, to the best of ENO's knowledge, representatives of the Springlake Neighborhood Association, the Eastern New Orleans Neighborhood Advisory Commission, the Edgelake Neighborhood Association, the North Kenilworth Homeowners' Association, the Lake Willow Neighborhood Association, and the Idlewood/Parkwood Homeowners' Association were in attendance. The sign-in sheet is attached hereto as Exhibit A.³

The second public outreach meeting was held on August 7, 2017 (6:00 p.m.) at the Algiers Regional Library, located in District C at 3014 Holiday Dr., New Orleans, Louisiana, 70131. Approximately twenty-seven individuals attended. While individuals in attendance did not disclose their affiliation with any community, civic, or other organizations, to the best of ENO's knowledge, representatives of the Alliance for Affordable Energy (the "AAE"), the Algiers Charter School Association, and the Bocage Civic Association were in attendance. The sign-in sheet is attached hereto as Exhibit B.

The third public outreach meeting was held on August 8, 2017 (6:00 p.m.) at The George and Joyce Wein Jazz and Heritage Center, located in District C at 1225 N. Rampart St., New

While individuals in attendance did not disclose their affiliation with any community, civic, or other organizations, to the best of ENO's knowledge, representatives of the AAE, GCE Services, and 350 Louisiana were in attendance. The fourth public outreach meeting was held on August 14, 2017 (6:00 p.m.) at Mid-City Library, located in District A at 4140 Canal St., New Orleans, Louisiana, 70119. Approximately twenty-one individuals attended. While individuals in attendance did not disclose their affiliation with any community, civic, or other organizations, to the best of ENO's knowledge, representatives of the AAE were in attendance. The sign-in sheet is attached hereto as Exhibit D.

The fifth public outreach meeting was held on August 15, 2017 (6:00 p.m.) at Rosa B. Keller Library, located in District B at 4300 South Broad St., New Orleans, Louisiana, 70125. Approximately twenty-two individuals attended. While individuals in attendance did not disclose their affiliation with any community, civic, or other organizations, to the best of ENO's knowledge, representatives of the AAE, 350 Louisiana, the Citizens Climate Lobby, and the 123 Walnut Condo Owners' Association were in attendance. 
