On December 14, 2017, the Council of the City of New Orleans ("Council") approved Resolution R-17-623 regarding the Application of Entergy New Orleans, LLC ("ENO") for the approval of its Supplemental and Amended Implementation Plan ("Plan") for Energy Smart Program Years 7-9. The Plan was filed on September 29, 2017. In Resolution R-17-623, the Council required ENO to file supporting models and work that demonstrate the reallocation of kWh savings forecasted for Program Year 7 to Program Year 8 while still achieving the combined pro-rated energy savings for Program Years 7 and 8. ENO submits the enclosed original and three copies of documents supporting the shift in kWh savings along with the previously-filed demonstration of the calculation of approved savings targets. ### **Identified Energy Savings Targets**

These are the Energy Savings targets identified in the initial implementation plan. Based on ENO's FERC Form 1 filings for those years, a three year average of Entergy New Orleans' net sales for calendar years 2013-2015 was utilized to determine the baseline for tracking achievement of the .2% annual energy savings increases. Program year 6 MWh savings totaled 19,336 MWh, which represented .34% of the baseline sales and the identified energy savings targets represent a .2% increase annually with PY7 equaling .54% of net sales, PY8 equaling .74% of net sales, and PY9 equaling .94% of net sales. Appendices 3,4 and 5 from the February 13, 2017 Implementation Plan include detail on calculations used to determine these energy savings targets.

### **Pro-rated Energy Savings Targets**

These are the Identified Energy Savings Targets with PY7 energy savings pro-rated to a 9 month period.

### **Current Plan Energy Savings Targets**

These are the Energy Savings targets identified in the approved revised implementation plan

#### Savings Shift

As demonstrated above, the reduction in targeted kWh savings for PY7 (-3,171,573 kWh) is more than covered by the excess in targeted kWh savings in PY8 (3,781,307 kWh). Proprietary models and other supporting documentation for the forecasted targets were provided along with the February 13, 2017 and September 29, 2017 Implementation Plan filings.
