MEMORANDUM IN SUPPORT OF ADVISORS' MOTION TO EXTEND PROCEDURAL DEADLINES

In Resolution No. R-17-430, issued August 10, 2017, the Council set forth the procedural schedule governing the 2018 Entergy New Orleans, LLC ("ENO") Integrated Resource Plan ("IRP") proceeding. In that Resolution, the Council also determined that it would utilize an independent consultant that reports to the Council to perform a DSM Potential Study for the 2018 IRP Proceeding. It had become apparent by September 2018, however, that the procedural deadlines set forth in Resolution No. R-17-430 did not sufficiently allow for the time that it would take the Council to procure a DSM Potential Study consultant.

Therefore, on September 28, 2017, the Council issued Resolution No. R-17-503 which altered the deadlines for responses to the Council's RFQ for a DSM Potential Study consultant, the Selection Review Committee's evaluation of responses, and the Council's choice of a DSM Potential Study consultant. In Resolution No. R-17-503, the Council acknowledged that further adjustments to the procedural schedule may be required and directed the Hearing Officer, working together with the Advisors, ENO and the parties in the docket to change or adjust other remaining dates where appropriate. Resolution No. R-17-503 also directed the Hearing Officer, where possible, to maintain the same relative time between actions or events set forth in the Initiating Resolution.

The initial date for the production of the DSM Potential Study was March 16, 2018. However, at this point in time, the Council has yet to execute the contract with the DSM Potential Study Consultant it has selected, therefore, the DSM Potential Study Consultant will not be able to produce a DSM Potential Study by the March 16, 2018 deadline. The Advisors, therefore request that the procedural schedule in this proceeding be adjusted as follows in order to allow for sufficient time for the Council to execute the contract with the chosen DSM Potential Study consultant, and for the DSM Potential Study consultant to complete the work. The following schedule also preserves to the greatest extent possible, the relative time between actions or events set forth in the Initiating Resolution, with the exception that an additional week has been added immediately before the deadline for Technical Meeting 3 of the Parties, CURO and the Advisors in order to avoid having the two-week period during which the meeting must be held fall over the 2018 Thanksgiving holiday.
