



**ENTERGY NEW ORLEANS, LLC PETITION FOR INTERVENTION
AND INCLUSION ON SERVICE LIST**

Entergy New Orleans, LLC (“ENO”) respectfully submits, through undersigned counsel, this Petition for Intervention (“Petition”) regarding the above-captioned proceeding. In support of this Petition, ENO represents the following:

I.

ENO is a limited liability company duly authorized and qualified to do business in the State of Louisiana, created and organized for the purposes, among others, of manufacturing, generating, transmitting, distributing, and selling electricity for power, lighting, heating, and other such uses; and ENO is engaged in the business thereof in the City of New Orleans.

II.

On June 21, 2018, the City Council of New Orleans (“Council”) adopted Resolution R-18-223 (“Resolution and Order Establishing a Docket and Opening a Rulemaking Proceeding to Establish Rules for Community Solar Projects”) and established the above-captioned proceeding.

III.

Although Council Resolutions that establish dockets and other proceedings affecting ENO’s business and the Council’s regulation thereof typically designate ENO and the Council’s Advisors as parties to such proceedings, R-18-223 did not designate ENO as a party to the

above-captioned proceeding. Accordingly, out of an abundance of caution, ENO files this Petition to ensure its ability to participate in a proceeding through which regulations applicable to ENO's business, and potentially affecting its customers, may be adopted.


ENO further requests that the foregoing individuals be placed on the Official Service List for this proceeding.


