<u>UNOPPOSED MOTION TO</u> EXTEND DATES IN PROCEDURAL SCHEDULE

The Advisors to the Council of the City of New Orleans ("Advisors"), through undersigned counsel, respectfully submit this Unopposed Motion to Extend Dates in Procedural Schedule in the above captioned docket as set by Order of Judge Jeffrey S. Gulin on November 20, 2018. By electronic mail dated April 10, 2019, the Advisors informed all parties to this docket that one of the Council's technical Advisors had suffered a death in his immediate family. As a result, the Advisors requested a limited extension of time in the remaining dates in the procedural schedule. No party has objected to the Advisors' request.

Counsel for Intervenor, Air Products and Chemicals, Inc., has requested that its witness, Maurice Brubaker, be allowed to testify at the hearing on either June 17, 2019 or June 18, 2019 because of a scheduling conflict in the latter part of the week. ENO has agreed to accommodate this request. Also, Counsel for Crescent City Power User's Group ("CCPUG") has indicated that its witness, Richard Baudino, is not available to appear at the hearing the week of June 17, 2019 but CCPUG has agreed to make Mr. Baudino available in New Orleans during the week of June 10, 2019 for deposition for the purpose of perpetuating his testimony.
