ENTERGY NEW ORLEANS, LLC'S MOTION TO DELAY ITS 2020 FORMULA RATE PLAN FILING FOR AN ADDITIONAL 30 DAYS

Entergy New Orleans, LLC ("ENO" or the "Company") respectfully submits this motion seeking to delay its 2020 Formula Rate Plan filing ("2020 FRP Filing") an additional 30 days, i.e., extending the current filing deadline of August 13, 2020 to September 12, 2020, for the reasons set forth herein. ENO further requests that all dates or time delays provided for in the Formula Rate Plan tariff be adjusted, for this proceeding only and only to the extent necessary, to provide for the same time delays in accord with the actual filing date of the FRP.

In early May 2020, the Council of the City of New Orleans unanimously approved ENO's unopposed request to delay its 2020 FRP filing by 60 days until June 29, 2020 to allow ENO and the Council to gain a somewhat better understanding of the extent of this coronavirus pandemic and its future effects, given the potential for financial, emotional, and in some cases, physical stresses on its customers. ENO, too, has begun to experience certain adverse financial effects associated with the pandemic. ENO noted at the time of its initial extension request that several regulators throughout the country have authorized delays in rate proceedings calling for a rate increase as a result of the pandemic.

The City of New Orleans and the State of Louisiana continue to monitor and react to the effects of COVID-19 on our community and continue to adapt the guidelines and restrictions to help protect the health of our citizens. Likewise, ENO and the Council continue to assess the

effects of this pandemic on the local economy, on ENO's residential, commercial, industrial and municipal customers, as well as on ENO's own financial condition. Given the significant uncertainties that remain with regard to such effects on the economy and the community, particularly as some students begin to return to classes, ENO respectfully requests an additional 30-day delay in making its 2020 FRP Filing.

WHEREFORE, for the reasons set forth herein, ENO respectfully requests that the Council grant this motion and extend ENO's FRP Filing deadline from August 13, 2020 to September 12, 2020, and that all dates or time delays provided for in the Formula Rate Plan tariff be adjusted, for this proceeding only and only to the extent necessary, to provide for the same time delays in accord with the actual filing date of the FRP. ENO requests that the motion be considered at the next meeting of the full Council, currently scheduled for August 20, 2020.
