# ENTERGY NEW ORLEANS, LLC'S MOTION TO EXTEND DEADLINE TO FILE REVISED FORM CSG-4 – STANDARD OFFER POWER PURCHASE AGREEMENT AND REVISED RATE SCHEDULE CSGF – COMMUNITY SOLAR GENERATING FACILITIES

Entergy New Orleans, LLC ("ENO" or the "Company") respectfully submits this Motion to Extend Deadline to File Revised Form CSG-4 – Standard Offer Purchase Power Agreement and Revised Rate Schedule CSGF – Community Solar Generating Facilities. As provided in Resolution No. R-23-507 ("Resolution") issued by the Council of the City of New Orleans ("Council"), the current deadline for the Company to file the revised forms is December 29, 2023. Through this Motion, the Company moves to extend the filing deadline until January 15, 2024, for the reasons set forth herein.

The Resolution requires the Company to file a revised Form CSG-4 – Standard Offer Purchase Power Agreement and a revised Rate Schedule CSGF – Community Solar Generating Facilities as may be appropriate to incorporate certain community solar provisions recently adopted by the Council. The Company has certain questions regarding the required revisions and has identified changes to other Community Solar forms that may help improve the application and interconnection process. The Company requires a brief period of additional time past the holidays to prepare the updated documents. Granting the requested extension would not adversely affect the interests of any other parties or the progress of this docket (as no remaining deadlines exist). The Company respectfully suggests the public interest would be served by allowing for this brief

extension to further consider and make any appropriate revisions to the forms referenced in the Resolution.

**WHEREFORE**, for the reasons set forth herein, ENO respectfully requests that the Hearing Officer grant this Motion and extend the current filing deadline from December 29, 2023, to January 15, 2024.
