City Council Resolution 22-219


Introduced by Councilmember Helena Moreno

- Resolves to protect the people of New Orleans and our environment from carbon capture storage projects that involve the underground disposal of carbon waste and the buildout of hazardous pipelines
- Recognizes the threats of climate change that include rising sea level, stronger storms, extended periods of extreme heat, and forceful tornadoes
- Affirms our Bill of Rights in the New Orleans Home Rule Charter to health that requires protection of our environment
- Supports transitioning to renewable and clean energy

City Council Resolution 22-219

(continued)

- Observes the growing number of companies proposing a new wave of polluting industries with carbon capture storage
- Reports the truth about our poor environmental regulations in the state that increases the risks and burdens of carbon waste projects
- Calls on the City to prohibit the build out of carbon capture storage projects and facilities
- Commits the City Council to not invest in or incentivize any carbon capture storage project



Climate goals: reduce greenhouse gas emissions by . . .

- Pres. Biden: 50-52 percent reduction of 2005 level by 2030 in United States
- Gov. Edwards: 40-50 percent reduction of 2005 level by 2030 and “net zero” by 2050 in Louisiana
