RESOLUTION AND ORDER ESTABLISHING PROCEDURAL SCHEDULE REGARDING ENTERGY NEW ORLEANS LLC RCPS COMPLIANCE PLAN COVERING COMPLIANCE YEARS 2023-2025

WHEREAS, pursuant to the Constitution of the State of Louisiana and the Home Rule Charter of the City of New Orleans ("Charter"), the Council of the City of New Orleans ("Council") is the governmental body with the power of supervision, regulation and control over public utilities providing service within the City of New Orleans; and

WHEREAS, pursuant to its powers of supervision, regulation, and control over public utilities, the Council is responsible for fixing and changing rates and charges of public utilities and making all necessary rules and regulations governing the terms and conditions of service, and to govern applications for the fixing and changing of rates and charges for public utilities; and

WHEREAS, Entergy New Orleans, LLC ("ENO" or "Company") is a public utility providing electric service and natural gas service to all of New Orleans; and

WHEREAS, on May 20, 2021, the Council adopted Resolution No. R-21-182 adopting a Renewable and Clean Portfolio Standard ("RCPS") for utilities providing electric service to New Orleans; and

WHEREAS, pursuant to the Compliance and Reporting requirements of the RCPS¹, ENO shall develop a three-year RCPS Compliance Plan every three years upon the conclusion of ENO's Triennial Integrated Resource Plan ("IRP") analysis, to be filed at the Council and served upon both the parties to the relevant IRP docket and the parties to Docket No. UD-19-01, with the opportunity for stakeholder comment prior to the Council's review; and

WHEREAS, ENO's Interim RCPS Compliance Plan is currently authorized by the Council through December 31, 2022;² and

WHEREAS, under the IRP procedural schedule adopted by the Council in Resolution No. R-20-257, as subsequently modified by Resolution No. R-21-73 and an Order issued by the Hearing Officer on April 7, 2021, ENO submitted its 2021 Integrated Resource Plan in Docket No. UD-20-02 on March 25, 2022; and

WHEREAS, on August 19, 2022 ENO submitted *Entergy New Orleans, LLC RCPS Compliance Plan Covering Compliance Years 2023-2025* ("RCPS Compliance Plan") to the Council setting forth its plan for complying with the RCPS for years 2023 through 2025; and

WHEREAS, the Council wishes to establish a procedural schedule allowing for public review of, and comment upon, the RCPS Compliance Plan.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NEW ORLEANS THAT:
