a year's overview

WHAT WE'VE BEEN UP TO

- Secured increased funding for the state's Weatherization Assistance Program, advocating for increase in WAP dollars as portion of LIHEAP (11% to 13% this year, and 15% next year)
- Re-invigorated the LPSC Energy Efficiency rulemaking process, with a now-expected mature rule in Quarter 4 of 2019.
- Confirmed New Orleans whole building data access, enabling a landlord portal and an expected ordinance requiring benchmarking of large commercial buildings, including multifamily buildings.
- Successfully advocated for a proceeding to develop formal rules for Entergy New Orleans' resource acquisition. The Rulemaking is underway, and the Alliance has firmly recommended competitive allsource solicitation to allow Demand Side Management resources to respond to Entergy RFPs.
- Participated in four Integrated Resource Planning proceedings, including Entergy New Orleans, Entergy Louisiana, Cleco, and Swepco. Negotiated for City Council's independent DSM potential study to represent ½ of DSM inputs for modeling assumptions.
- Collaborated on a Climate Action Equity Project, working with community members and local advocates on developing a plan to ensure the city's Climate Action Strategy moves forward with community priorities and equity.
- Successfully advocated for the New Orleans City Council to open a Renewable Portfolio Standard rulemaking docket.

WHERE WE'VE BEEN


- Hosted a Renewable Portfolio Standard Symposium for 60 community members and national partners.
- Defended Cleco customers against the \$54.3M cost of coal-ash clean up associated with old power generators purchased by the company.
- Protected Louisiana's solar customers from a radical change in net energy metering policy that would devalue their clean energy.
- Secured community solar rules for New Orleans with low-income customer carve-outs and rates.
- Contributed to a regional study on Solar + Storage and the added resilience benefits of these two clean technologies when paired and strategically sited on a distribution grid.
- Negotiated lower-costs on the first 140 MW of utility scale solar in Louisiana. (90 MW Entergy New Orleans, 50 MW Entergy Louisiana)
- Engaged in a total of 26 formal proceedings at the Louisiana Public Service Commission and the New Orleans City Council.
- Hosted 26 interns, totaling nearly 2,500 hours of volunteer research and administrative support.
- Hosted or attended over 50 community and organizing meetings.


