### Dear Clerk of Council:

Please find enclosed for your handing Entergy New Orleans, LLC's ("ENO") Securitized Storm Cost Offset Rider II ("Rider SSCOII") Annual Revision to the Rate Adjustment Filing as shown in Attachment A to Rider SSCOII, supporting calculations, and a summary of the resulting effects of the rider on typical bills. ENO submits this filing electronically and will submit the requisite original and number of hard copies once the Council resumes normal operations or as you direct.

Pursuant to Council Resolution R-22-437 (As Corrected) issued on October 6, 2022 in regard to Application of Entergy New Orleans, LLC and the Louisiana Utilities Restoration Corporation for Authority to Fund and Finance Storm Recovery Reserves, and Related Relief in Docket No. UD-22-01 (the "Financing Order"), please find enclosed for your handing Entergy New Orleans, LLC's ("ENO") Annual Revision to the Securitized Storm Cost Offset Rider II ("Rider SSCOII") including Attachment A thereto, supporting calculations, and a summary of the resulting effects of the rider on typical bills.

Each annual revision to the rate adjustment shall be filed with the Council of the City of New Orleans ("Council") not less than fifteen days prior to the first billing cycle of the month in which the revised storm recovery charges will be in effect. The Council Utility Advisors will have 15 days after the date of the annual adjustment filing in which to confirm the mathematically accuracy of the Servicer's adjustment, after which the charge will become effective.

However, any mathematical correction not made prior to the effective date of the storm cost offset charge will be made in future true-up adjustment filings and will not delay the effectiveness of the storm recovery charge.

Using the formula approved by the Council in the Financing Order, this filing modifies the variables used in the calculation and provides the resulting modified Storm Cost Offset Charge. The supporting workpapers show the resulting Storm Cost Offset Charge expressed as a

percentage of base rate revenues and calculated in accordance with the Financing Order. The assumptions underlying the current Storm Cost Offset Charge were filed by ENO in a Rate Adjustment Filing dated January 17, 2024. The SSCOII Rate is -0.5686% and will commence billing for monthly customer bills rendered on and after the first billing cycle of May 2025.

The following materials are provided with this letter:

- 1) NOTICE identifying the nature of the enclosed filing and stating the right of the public to inspect and copy same;
- 2) A cover sheet Summary of the enclosed filing summarizing the contents of and describing the effects thereof; and
- 3) A copy of the referenced filing.

It is the Company's request and understanding that your office will arrange for prompt and proper publication of the documents in the official Journal of the City of New Orleans (the "Times-Picayune"), the charges for which the Company will honor upon receipt of an invoice. Further, ENO will make available, at the main library and at every operational satellite branch of the New Orleans Public Library within the City of New Orleans, the office of the Clerk of Council of the City of New Orleans, and also at the ENO Customer Care Center located in Orleans Parish, a copy of the filing for public inspection and copying.

The supporting workpapers for the Annual Revision to the Rate Adjustment calculation contain information that is designated as Highly Sensitive Protected Materials ("HSPM"). The HSPM materials are being produced only to the appropriate Reviewing Representatives under the terms of the provisions of the Official Protective Order adopted pursuant to Council Resolution R-07-432 relative to the disclosure of Protected Materials. The HSPM materials (along with the revised Attachment A containing the SSCOII Rate) are being produced to the Council Advisors under separate cover on April 15, 2025.

# SUMMARY OF ENO'S RATE ADJUSTMENT SHOWN ON ATTACHMENT A TO THE SECURITIZED STORM COST OFFSET RIDER II ("RIDER SSCOII")

Pursuant to the Financing Order adopted in Resolution R-22-437 (As Corrected) in Council Docket No. UD-22-01 ("Financing Order"), Entergy New Orleans, LLC ("ENO") must file an annual revision to the Rate Adjustment shown in Attachment A to the Securitized Storm Cost Offset Rider II ("Rider SSCOII"). Rider SSCOII is the mechanism through which ENO is to address any adjustments or effects related to the financing and/or storm recovery process authorized in the Financing Order.

The estimated effects of the annual adjustment flowing through Rider SSCOII will be implemented beginning on the first day of the first billing cycle of May 2025. The effects of the annual revision adjustment on the monthly electric bill through Rider SSCOII authorized by the Council in the Financing Order are as follows:
