**RESOLUTION AND ORDER ESTABLISHING A PROCEDURAL SCHEDULE
REGARDING ENTERGY NEW ORLEANS LLC'S ENERGY SMART
IMPLEMENTATION PLAN FOR PROGRAM YEARS 16-18**

WHEREAS, pursuant to the Home Rule Charter of the City of New Orleans ("Charter"), the Council of the City of New Orleans ("Council") is the governmental body with the power of supervision, regulation and control over public utilities providing service within the City of New Orleans; and

WHEREAS, pursuant to its powers of supervision, regulation, and control over public utilities, the Council is responsible for fixing and changing rates and charges of public utilities, making all necessary rules and regulations governing the terms and conditions of service, applications for the fixing and changing of rates and charges for public utilities, and all other regulatory proceedings; and

WHEREAS, Entergy New Orleans, LLC ("ENO") is a public utility providing electric service to all of New Orleans; and

WHEREAS, the Council approves Energy Smart program designs, savings targets, and budgets for three prospective Program Years every three years upon the conclusion of ENO's Triennial Integrated Resource Plan ("IRP") analysis; and

WHEREAS, the Energy Smart Program is currently authorized by the Council through the end of Program Year 15 on December 31, 2025; and

WHEREAS, on June 8, 2023, the Council adopted Resolution No. R-23-254 (“Initiating Resolution”), establishing the procedural schedule for ENO’s 2024 IRP; and

WHEREAS, the Initiating Resolution’s procedural schedule has been completed; and

WHEREAS, on June 16, 2025 ENO submitted the *Application of Entergy New Orleans, LLC for Approval of the Energy Smart Implementation Plan for Program Years 16 through 18* (“PY 16-18 Implementation Plan”) to the Council setting forth its Program Years 16-18 program designs, budgets, kWh savings targets, and requested utility performance incentives; and

WHEREAS, in its PY 16-18 Implementation Plan, ENO further requested the Council approve ENO’s selections for third-party administrators and third-party evaluators for Program Years 16-18; and

WHEREAS, the Initiating Resolution’s procedural schedule requires adoption of a procedural schedule related to the Energy Smart Implementation Filing to allow for public review and comment; **NOW THEREFORE**

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NEW ORLEANS, That the following procedural schedule is adopted to consider the PY 16-18 Implementation Plan:

1. Comments on the PY 16-18 Implementation Plan shall be filed no later than Tuesday, August 26, 2025. Comments should address the following:
 - a. whether the Implementation Plan should be approved for all subject program years or some subset thereof;
 - b. which programs, if any, should be eliminated, reduced, or expanded; and

- c. whether ENO's selections for Third Party Administrators and Third-Party Evaluators for Program Years 16-18 should be approved.

2. Reply Comments shall be filed no later than Friday, September 12, 2025.
