On October 24, 2024, the Council adopted UD-24-624 ("Initiating Resolution, initiating a preceding and procedural schedule to evaluate ways to increase the availability of distributed energy resources ("DER").

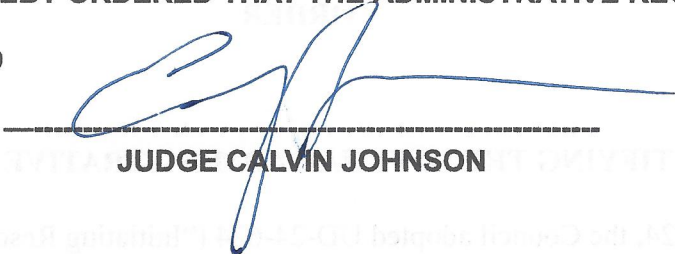

The initiating resolution directed the Advisors to submit a report on June 2, 2025. On December 20, 2024 parties filed changes to existing policies and proposed new programs. On April 29, 2025, the parties participated in a second technical conference. The Advisors Report was filed on July 16, 2025. Parties filed comments on the Advisors Report, August 8, 2025. Parties filed revised reports September 22, 2025.
