ORDER

WHEREAS, on August 20, 2020, the Council of the City of New Orleans (“City Council”) adopted Resolution No. R-20-257, *In Re: 2021 Triennial Integrated Resource Plan of Entergy New Orleans, Inc.*, which contained the procedural schedule governing the 2021 Triennial Integrated Resource Plan (“IRP”).

WHEREAS, on February 19, 2021, the Advisors to the Council of the City of New Orleans (“Advisors”) filed *Advisors’ Motion to Extend Procedural Deadlines*, seeking to extend certain procedural deadlines in the 2021 IRP.

WHEREAS, on February 26, 2021, ENO filed *Entergy New Orleans, LLC’s Reply to Advisors’ Motion to Extend Procedural Deadlines*, wherein it proposed an alternate procedural schedule.

WHEREAS, on March 26, 2021, the City Council of New Orleans’ Technical and Legal Advisors, the Council Utilities Regulatory Office, the City Council of New Orleans’ Independent DSM Consultant, Entergy New Orleans, LLC, and all of the Intervenors, including the Alliance for Affordable Energy, Air Products and Chemicals, Inc., Southern Renewable Energy Association, Sustainable Energy Economy Solutions, 350 New Orleans, National Audubon Society, and Gulf States Renewable Energy Industries Association met to discuss the procedural schedule and agreed to modify the schedule as follows:
