Energy Efficiency: This year's energy efficiency programs continued to grow across the state, including New Orleans. We advocated for more robust programs and rules at the Public Service Commission and the New Orleans City Council. Over the course of this year we engaged with four utility Integrated Resource Plans, advocating for efficiency to play a foundational role in the state's energy mix. We continued to work with partners in the housing and health sectors to educate on the power of efficiency to reduce housing costs, improve health and comfort, and grow a clean energy workforce. We worked with the City of New Orleans to develop an energy benchmarking rule to ensure large buildings share their performance to increase transparency and drive greater energy savings. We also fought for efficiency through a rate-case, locking in dedicated funding for future efficiency programing. Finally, we engaged at the Louisiana Housing Corporation to advocate for a larger portion of energy program dollars to be dedicated to the weatherization assistance program for low income customers.

Form 990, Part III, Line 4b - Program Service Accomplishments

Clean Energy: This year we were successful in developing the first community solar rules in the southeast region. The New Orleans City Council has approved community solar rules, which will enable many more residents and businesses to access clean and affordable energy and reduce our dependence on fossil fuels. We also worked with a growing coalition of organizations to secure a rulemaking for a Renewable Portfolio Standard, conducting education and outreach with community members around the city, holding symposia, drafting rules, and pulling together expertise from around the country to create a Resilient Renewable Portfolio Standard proposal. Through our advocacy, Entergy New Orleans' latest Integrated Resource Plan shows that the most cost effective portfolios to provide power to their customers is with

clean, renewable energy. Finally, we were engaged in the development of the first 140MW of utility scale solar in Louisiana, from four separate projects. At the Public Service Commission, we continued our work protecting the right of solar-choice for full and fair net-energy metering. We built and maintained a website for the effort and conducted phone banking as well as a postcard campaign to engage existing solar customers.

Form 990, Part III, Line 4c - Program Service Accomplishments

Consumer Protection: We engaged this year in a rate case, the acquisition of a generation fleet by one of Louisiana's largest utilities, and conducted research into the actual costs of the existing energy system. Through these research, analyses, and applied educational advocacy efforts, we saved Louisiana rate-payers well over \$75M. One of the largest savings we secured was related to requiring a utility to take responsibility for the extreme costs of its coal-fleet, rather than hoisting those costs onto rate-payers. We pushed regulators in the region to conduct reviews of large, underperforming power plants, and we successfully advocated for policies that will ensure rate-payers get the least cost power when utilities are acquiring new assets. We conducted outreach meetings around the state to help individuals and organizations better understand what they are paying for through their energy bill, and how they can take back their power. We also broadened our reach with our weekly radio program, the People's Power Hour, on local community station 102.3 WHIV, hosting guests each week.
